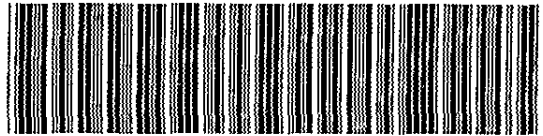

**FOR**

**ARTICLE ONE**

The name of the corporation is D J EXTERIORS, INC. The principal office of the corporation is 889 Florida Avenue Suite A, Palm Harbor, Florida 34683.

**ARTICLE TWO**

The period of duration is perpetual.

**ARTICLE THREE**

The purpose for which the corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Florida Corporation Act.

The aggregate number of shares, which the corporation shall have authority to issue, is 1,000 with no par value.




