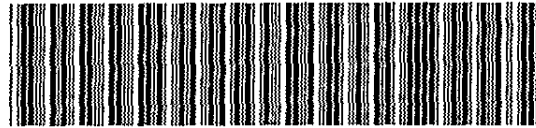


ARTICLE NINE
