ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of Yhi Associates Corp. under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

#### **ARTICLE I. NAME AND ADDRESS**

The name of the corporation is Yhi Associates Corp. The street address of the initial principal office of the corporation is 250 N. Orange Avenue, Penthouse Suite, Orlando, Florida 32801. The mailing address of the corporation is 250 N. Orange Avenue, Penthouse Suite, Orlando, Florida 32801.

#### ARTICLE IL COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence upon filing of these Articles with the Secretary of State of the State of Florida, and continue in perpetuity until dissolved under the laws of the State of Florida.

No preemptive rights are to be granted to shareholders.

#### ARTICLE V. INITIAL REGISTERED OFFICE AND AGENT

#### ARTICLE VI. INITIAL BOARD OF DIRECTORS
