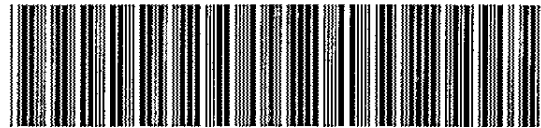

The undersigned subscriber to these Articles of Incorporation make, subscribe and acknowledge the following Articles of Incorporation under the laws of the State of Florida.-

ARTICLE I - NAME OF CORPORATION

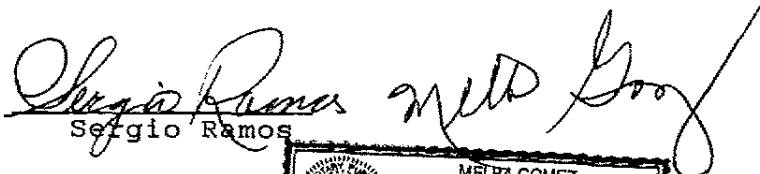
ARTICLE IX - AMENDMENT TO ARTICLES

These Articles of Incorporation may be amended in any manner permitted by law.-

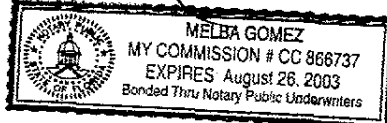
ARTICLE X - RESTRICTIONS ON TRANSFER OF STOCKS

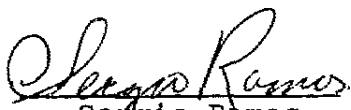
