
**ARTICLE VIII - POWERS**



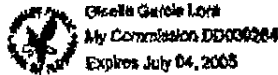


