# ARTICLES OF INCORPORATION OF

#### FASA, INC.

The undersigned, in order to form a corporation for the purpose hereinofter states), under and pursuant to the General Corporation Act of the State of Florida, do hereby certify as following:

#### ARTICLE I

NAME

The name of this corporation is: FASA, INC.

- D) To sell, manage, improve, develop, assign, transfer, convey, lease, anhicase, pledge or otherwise encumber the lands.
- E) To borrow money with or without plodge of or mortgage on all or any of its property, real or personal, as security and to loan and advance money upon mortgages on personal or real property or on either of them.
- F) To buy, sell, and deal in, with or without guarantee of payment theroof, bonds and mortgages and other like accurities and other kinds of property, whether real or personal, not prohibited or specifically excepted by law, and in do and proscente any facts or things incidents to or proper in connection with the carrying on of the business of the corporation.
