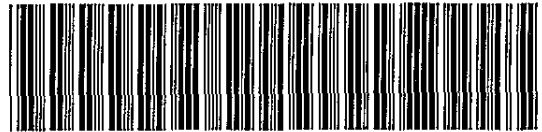



ARTICLE ONE - NAME & ADDRESS

The name of the Corporation is **C & M CUSTOM AFGHANS INC.**, and the principle place of business of this corporation shall be: 751 25TH Avenue North, St Petersburg, FL 33704-3313.


