



ARTICLES OF INCORPORATION  
OF  
THAI TONY CAFÉ, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is THAI TONY CAFÉ, INC. The mailing address is 10166 N.W. 51<sup>ST</sup> Terrace, Miami, FL 33178.

ARTICLE II - PURPOSE

The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the laws of Florida and the United States.

ARTICLE III - DURATION

This corporation shall have perpetual existence commencing on the date of execution and acknowledgement of these Articles of Incorporation.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 500 shares of \$1.00 par value Common Stock which shall be designated "common shares".

ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 10166 n.w. 51<sup>st</sup> Terrace, Miami, Fl 33178 and the name of the initial registered agent of this corporation at this address is Thongsuk Phannaphop.

ARTICLE VII - INITIAL BOARD OF DIRECTORS
