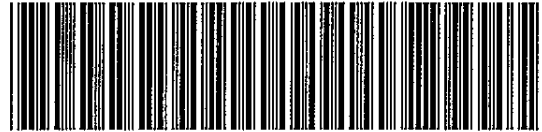

ARTICLES OF INCORPORATION  
OF

**MARKET POWER ECONOMETRICS AND MANAGEMENT CORP.**

The undersigned incorporator(s), being of legal age and natural person do hereby subscribe to, acknowledge and file the Articles of Incorporation for the purpose of forming a Profit Corporation under Chapter 607 of the Florida Statutes, hereby adopt(s) the following Articles of Incorporation.

Article I

The name of this Corporation shall be:

Article II

This Corporation may engage in any activity or business permitted under the laws of the State of Florida and shall commence existence upon the date of filing with the Division of Corporations, State of Florida, and shall have perpetual existence.

Article III

The general nature of business of this corporation is to transact any and all lawful business, Economic and Management Consulting Firm which specializes in the provision of management, economic and operations research services, including the collection, analysis, reporting and sales of economic and business statistical and other data, as well as in the performance of economic and business studies, plans, expert opinions development for sale to individual, business and corporate clients in the United States and abroad.

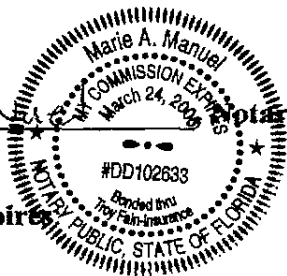
