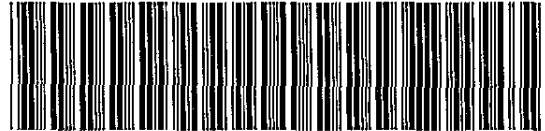

**Articles of Incorporation
Of

The undersigned for the purpose of forming a corporation, under the laws of the **State of Florida**, hereby adopt the following **Articles of Incorporation**.

Article I

The name of the corporation is **Main Street Bakery & Deli INC.**

Article II

The corporation may engage in any activity or business permitted under the laws of the **United States and the State of Florida**.

Article III

The maximum number of shares of the corporation is authorized to have outstanding at any one time is 100 shares of common voting stock with a par value of \$1.00 per share, and 100 shares of non-voting preferred stock with a par value of \$1.00 per share.

Article IV

The amount of Capital with which the corporation will begin business is One Hundred (\$100.00) dollars.

Article V

This corporation is to exist perpetually.

Article VI

The initial post office address of this principle office of this corporation is 5544 North Main Street, Jacksonville, Florida 32206. The board of directors may from time to time move the principle office to any other address in Florida.

Article VII

This corporation shall have three directors initially. The number of directors may be increased or reduced from time to time by the by laws unanimously adopted by the stockholders, but shall never be more than three (3) or less than one (1).

Article VIII

Article VIII

The names of the subscribers to these, Articles of Incorporation are as follows: The number of shares of the stock that they agree to take, and the value of the consideration, therefore is. (33) thirty three shares for \$33.30 consideration to Emily Zifteh, (33) thirty three shares for \$33.30 consideration to Jennifer Charipar, and (33) thirty three shares for \$33.30 consideration to James Huntress.

Article X

These **Articles of Incorporation** may be amended in the manner provided by the law. Every amendment shall be approved at a stockholders meeting by a majority of the stock entitled to vote thereon, unless all the directors and stockholders sign a written statement manifesting their intention that a certain amendment to the **Articles of Incorporation** be made.
