

ARTICLES OF INCORPORATION

GLOBAL MARKETING & ADVERTISING, INC.

ARTICLE I

CORPORATE NAME

ARTICLE II

PURPOSE

The nature and purpose of the business to be transacted by this corporation shall be: marketing and advertising. To transact any or all lawful business for which corporations may be incorporated under the Florida General Corporations Act. To do all and everything necessary or proper for the accomplishment of the objects enumerated or necessary or incidental to the protection and benefit of the corporation and in general, to carry on any lawful business necessary or incidental to the attainment of the objects of the corporation whether or not such business is similar in nature to the objects set forth herein, provided the same be not inconsistent with the laws under which the corporation is organized.

DURATION AND COMMENCEMENT OF EXISTENCE
