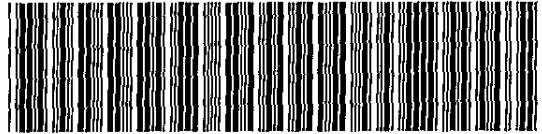

ARTICLES OF INCORPORATION
OF

ARTICLE I.

NAME

The name of this corporation is BRAUN GROUP INTERNATIONAL, INC.

ARTICLE II.

PRINCIPAL OFFICE

The principal office of this corporation is 1120 North Shore Drive, Suite 901, St. Petersburg, FL 33701 and the mailing address of this corporation is 200 2nd Avenue South, No. 241, St. Petersburg, FL 33701.

ARTICLE III.

DURATION: EFFECTIVE DATE

This corporation shall exist perpetually, commencing as of March 4, 2003.

ARTICLE IV.

PURPOSES

This corporation may engage in any activity or business permitted under the laws of the United States of America and of this State.

ARTICLE VII.
INITIAL BOARD OF DIRECTORS

This corporation shall have one (1) director initially. The number of directors may be either increased or decreased from time to time as provided in the Bylaws, but shall never be less than one. 
ARTICLE VIII.
