

ARTICLES OF INCORPORATION OF GIVE GROUP, INC.

The undersigned does hereby subscribe to, acknowledge and files the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is GIVE GROUP, INC.

ARTICLE II - PURPOSE
