

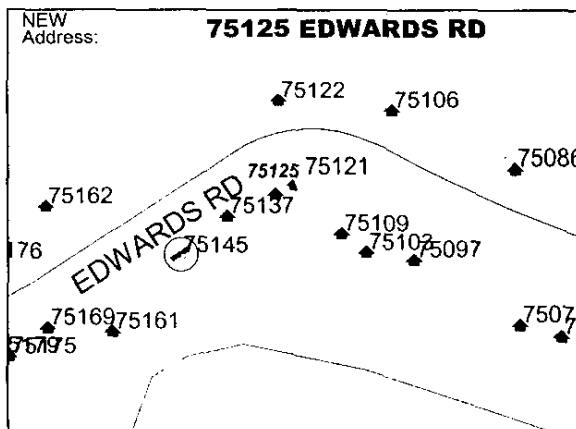

ALL YULEE RESIDENTS & BUSINESSES

In accordance with Nassau County addressing Ordinance 2003-13, the 9-1-1 Mapping and Addressing Office is notifying residents and businesses of their new addresses. All address changes are for physical street addresses only; post office numbers inside the Yulee Post Office will not be changed.

The address changes are necessary to insure all structures can be readily located while minimizing emergency response times for Fire, Rescue, and Law Enforcement agencies in our rapidly growing County. We apologize for any inconvenience you may experience during this transition period.

The United States Postal Service will strive to ensure that mail service will not be interrupted. Old addresses will remain valid for 6 months after the new addresses are issued. The Yulee Post Office has change of address post cards (USPS form # 3576), which can be used to notify correspondents (cards require only \$0.23 postage).

For your use we have compiled a list of some of the people/places you might need to contact with your new address. Keep this list for reference, making sure to notify any others of your address change.

Please review your new address and the 9-1-1 information in the Notifier letter carefully. Call our office (Mon-Fri 8am-5pm) to let us know that you have received the Notifier letter and the information is correct, needs any changes, or if you have any questions.

All residents are required to place 3 1/2 inch numbers (businesses 6 inch numbers) that are visible from the roadway so that you will be in compliance with Nassau County addressing Ordinance. We will furnish more details on this in our Post-Notifier letter in about 3 months.
