

# ARTICLES OF INCORPORATION

OF

# SCORPIO OF SOUTHWEST FLORIDA, INC.

These Articles of Incorporation are executed by the undersigned for the purpose of forming a corporation pursuant to the Florida General Corporation Act, as particularly set forth in Chapter 607 of the Florida Statutes.

# ARTICLE I. NAME.

The name of this corporation shall be named and known as SCORPIO OF SOUTHWEST FLORIDA, INC.

# ARTICLE II. DURATION.

The corporation shall commence upon the filing of these Articles and shall have perpetual existence thereafter.

# ARTICLE III. PURPOSE.

The purpose for which the corporation is organized is the transaction of any and all lawful business for which a corporation may be incorporated under the Florida General Corporation Act, as the same may from time to time be amended.

# ARTICLE IV. CAPITAL STRUCTURE.

The aggregate number of shares of capital stock which this corporation shall have authority to issue shall be tenthousand (10,000) shares of common stock, all of the same class and each having a par value of One Dollar (\$1.00).
