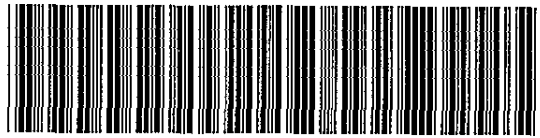

ARTICLES OF INCORPORATION

OF

S.G. LUTZ FINANCIAL STRATEGIES, P.A.

The undersigned, for the purpose of forming a Corporation under the laws of the State of Florida in accord with Chapter 607 Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is S.G. LUTZ FINANCIAL STRATEGIES, P.A.

ARTICLE II - DURATION

The term of existence of the corporation is perpetual and shall commence upon the date of the filing of these Articles of Incorporation.

ARTICLE III - PURPOSE

The corporation is organized for the purpose of providing financial services to include the sale of insurance products, annuities and related and similar products consistent with the license of Steven G. Lutz as provided for by the Florida Department of Insurance, License No.: E020906, and in accord with the laws of the State of Florida for which corporations may be incorporated under the Florida General Corporation Act and further to engage in all business matters necessary and proper in connection with such practice or consistent with any future licensing of Steven G. Lutz.

ARTICLE IV - CAPITAL STOCK

The aggregate number of shares which the corporation has authority to issue is One Hundred (100.00) shares all of which shall be of a single class of voting common shares having a par value of Ten Dollars (\$10.00) per share.

ARTICLE V - REGISTERED OFFICE AND REGISTERED AGENT
