ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is RYAN REAL ESTATE, INC., and the principal address and principal place of business is 711 NORTH SHERRILL STREET, TAMPA, FLORIDA 33609.

ARTICLE II - REGISTERED OFFICE AND AGENT

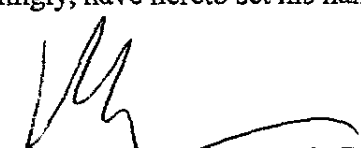
