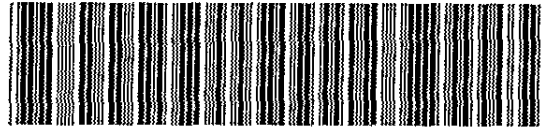

Article I

Name. The name of this Corporation is: Kids on the Move - Robin Andersen, Inc.

Article II

Place of Business and Mailing Address. The principal place of business and mailing address is 1023 Northwest 16th Avenue, Gainesville, Florida, 32609.

Article III

Purpose. The purpose of this Corporation is to engage in any activities or businesses permitted under the laws of the United States and under the Florida General Corporation Act including, but not limiting, the acquisition of life insurance bonds, debentures, commodities, leaseholds, options, puts and calls, easements, mortgages, notes, mutual funds, investment trusts, common trust funds, voting trust certificates, and any class of stock or right to subscribe for stock, including trading on margin.

Article IV

Capital Stock. This Corporation is authorized to issue 1000 shares of One Dollar (\$1.00) par value common stock.

Article V

Initial Board of Directors. This Corporation shall have one (1) Director initially. The number of Directors may either be increased or diminished from time to time by the By-Laws, but it shall never be less than one. Article VI

Initial Registered Office and Agent. The street address of the initial registered office of this Corporation is 1023 Northwest 16th Avenue, Gainesville, Florida, and the name of the initial registered agent of this Corporation at that address is ROBIN P. ANDERSEN.

Article VII

By-Laws. The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and shareholders.

Article VIII

Duration. The period of duration of this Corporation shall be perpetual, commencing on the date of execution and acknowledgment of these articles.
