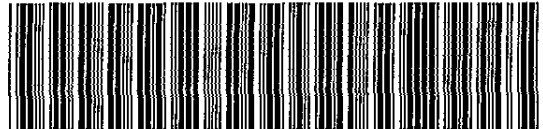

The undersigned, for the purpose of forming a corporation under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation.

ARTICLE I – NAME AND OFFICE BUSINESS ADDRESS

The name of this corporation is **REDONDO & ASSOCIATES, INC.** The principal business and mailing address for the corporation is 15706 SW 72nd Street, Suite 12, Miami, Florida 33193.

ARTICLE II – DURATION

This corporation shall exist in perpetuity.

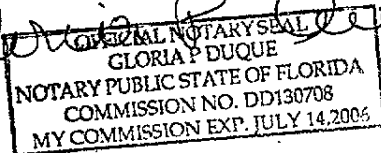
