ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of the corporation is: OMNI INVESTMENT CORPORATION

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE


ARTICLE XI - INDEMNIFICATION


