**ARTICLES OF INCORPORATION  
OF  
FIRST IMPRESSIONS FETAL ULTRASOUND, INC.**

In compliance with the requirements of chapter 607, Florida Statutes, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the Corporation ("Corporation") is First Impressions Fetal Ultrasound, Inc.

**ARTICLE II**

The existence of the Corporation shall begin on the date the Articles of Incorporation are filed with the Secretary of State of Florida and shall be perpetual.

**ARTICLE III**

The street address of the principal office of the Corporation is 4552 Bayside Drive, Milton, Florida 32583.

**ARTICLE IV**

The maximum number of shares this Corporation is authorized to issue is 100, par value \$1.00 per share, all of which shall be Common Shares. 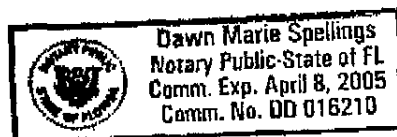
