**ARTICLES OF INCORPORATION

*The Undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.*

**ARTICLE I - NAME**

The name of the Corporation is: **Flagler Plumbing, Inc.**

**ARTICLE II - ADDRESS OF THE PRINCIPAL OFFICE**

Located in **Flagler County**, the principal place of business and street address of this corporation shall be: **170 Old Moody Blvd- Bunnell, Fl 32110**

**ARTICLE III - PURPOSE**

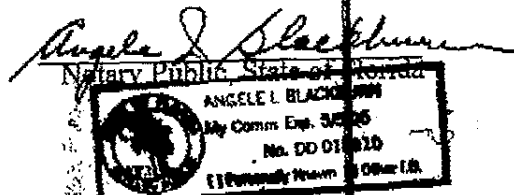
