ARTICLES OF INCORPORATION
For

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the Corporation is Tech Solutions of South Florida, Inc. Principal place of business is 1040 SW 61st Ave., Margate, FL 33068.

ARTICLE II: DURATION

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual.

ARTICLE III: PURPOSE

ARTICLE IV: SUBCHAPTER S CORPORATION

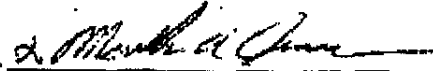
ARTICLE VIII: INCORPORATOR

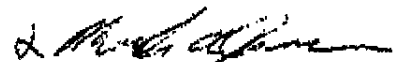
