Please find enclosed a Form 4810 and the Florida state corporation closure papers for Florida Aerospace Transport, Inc., EIN 570448917. This corporation was started in March, 2003 and had a total of \$660.00 investment in it. Most of this has gone to obtaining an EIN, for registering the corporation with the State of Florida, and for the annual Uniform Business report required by Florida. There might be \$200.00 of the original investment left. It never purchased nor sold anything, never had a profit, and never filed a tax return.

With regard to n ot filing a form 1120S for 2003, we had no income and made no profit, so we assumed we had no requirement to file.

We are closing the corporation because its original business plan could not be carried out. We have not been able to negotiate a Space Act Agreement to develop and charter outbound cargoes from the Kennedy Space Center Shuttle Landing Facility as originally planned. We have not had the personal time and attention to devote to the work nor have we been able to develop an alternative business plan. Continuing the company at a loss seems to us to make no sense.

Therefore, these papers and this letter are intended to elicit from the Internal Revenue Service the necessary authorization to proceed to disband the business and for you to rescind the EIN. Since the business is now closed and has never earned a profit, it is our expectation that we owe no tax and that you will so advise us, if you would be so kind.
