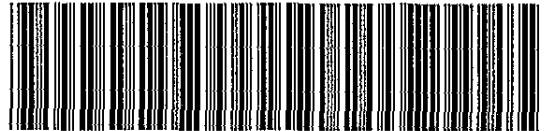

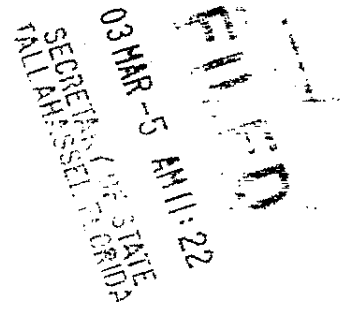
## ARTICLES OF INCORPORATION
