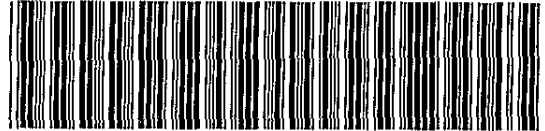

OF

ARTICLES I - NAME

The name of the corporation shall be TINA MASTERS, PA.

ARTICLE II - DURATION

This corporation shall have perpetual existence and shall commence upon filing hereof.

The name and address of the Incorporator is Tina Masters, 19547 Caloosa St., Sugarloaf, Fl 33042


ARTICLE IX - OFFICERS
