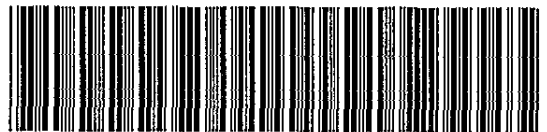

ARTICLE I – NAME

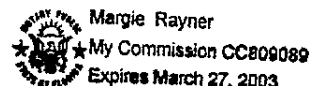
