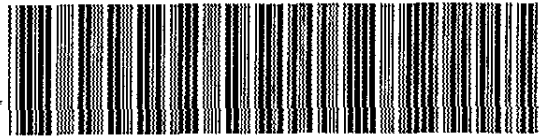

ARTICLE I - NAME

The name of this Corporation is Nationwide Refreshment Services, Inc.; the mailing address is 3700 Island Boulevard, Suite 408, Aventura, Florida 33160.



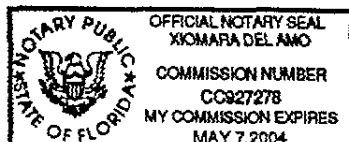
