We, the undersigned, **JEFFREY L. HOMER, NATHAN E. DOUGHERTY** and **JOSE ROLLON,** do hereby prepare these Articles of Incorporation for the purpose of forming a corporation for profit as provided under the laws of the State of Florida.

- 1. <u>NAME</u>. The name of the corporation shall be **HARBOUR RESTAURANTS**, **INC**. a Florida corporation.
- 2. **PURPOSE.** The said corporation is to be in the business of engaging in any and all activities allowable under the laws of the State of Florida.
  - 3. **GENERAL POWERS.** The Association shall have the following powers:


