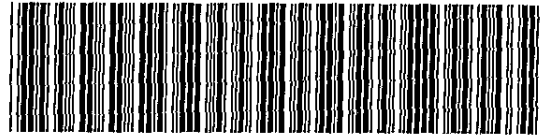



**ARTICLES OF INCORPORATION  
OF**

**BLUE SPRINGS MUDD BOG, INCORPORATED**

In compliance with the requirements of Florida Statute Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the Corporation ("Corporation") is BLUE SPRINGS MUDD BOG, INCORPORATED.

**ARTICLE II**

The existence of the Corporation shall begin on the day the Articles of Incorporation are filed with the Secretary of State.

**ARTICLE III**

The street address of the principal office of the Corporation is 3086 Calhoun Road, Marianna, Florida 32446.

**ARTICLE IV**

The maximum number of shares this Corporation is authorized to issue is 100, par value \$1.00 per share, all of which shall be Common Shares.
