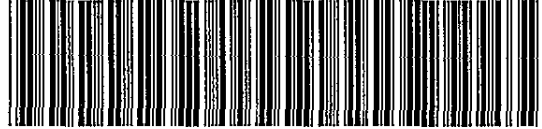

ARTICLES OF INCORPORATION
OF

ARTICLE I -- NAME




