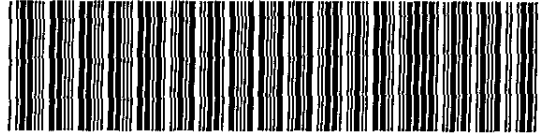



**ARTICLES OF INCORPORATION

The undersigned, being a person competent to contract to subscribe to these Articles of Incorporation to form a profit corporation under the laws of the State of Florida.

**ARTICLE I**

**NAME:** The name and mailing address of this corporation is:
