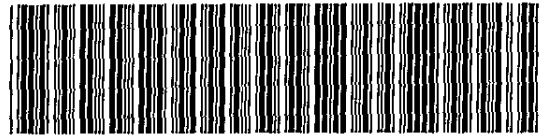

ARTICLE I

NAME

The name of this corporation is **FINLAY ORTHOPEDIC CENTER, Inc.**

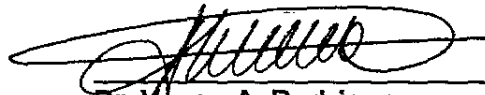
