ARTICLES OF INCORPORATION

OF

J.D. OF MIAMI-DADE COUNTY, INC.

The undersigned incorporator hereby executes, acknowledges and files with the Florida Department of State the following Articles of Incorporation (the "Articles") for the purpose of organizing a corporation under the Florida Business Corporation Act (the "Act"):

ARTICLE I - NAME

The name of the corporation is J.D. OF MIAMI-DADE COUNTY, INC.

ARTICLE II - PRINCIPAL OFFICE

The initial principal place of business or mailing address of the Corporation shall be located at 12887 SW 17 Street, Miami, Florida 33175.
