ARTICLE I.

The name of this Corporation is: BAVARIAN WOOD FLOORING CORP.

ARTICLE II.

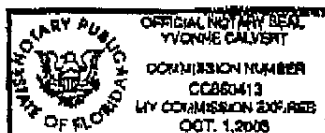

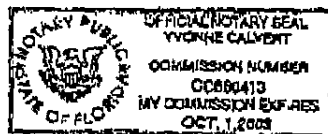


