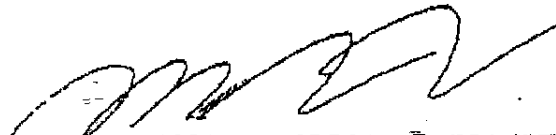

## PREEMPTIVE RIGHTS

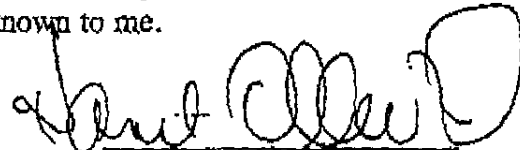

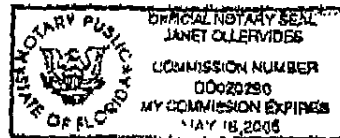
