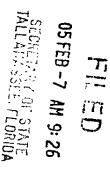

OSFEB 7 AM 9:26 The following provisions of the Articles of Incorporation of MICHAEL E. WYNN, P.A Florida Professional Corporation, filed in Tallahassee, March 7, 2003, be and they hereby are amended in the following particulars:

- First paragraph is hereby amended to read as follows: "The undersigned natural 1. person, competent and licensed to practice law in the State of Florida, acting as Incorporator for the purpose of forming a Professional Service Corporation for profit under the provisions of Section 607.
