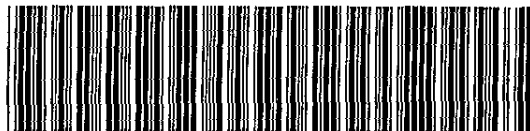

ARTICLES OF INCORPORATION OF FLORIDA FLEET TRANSPORTATION, INC.

The undersigned acting as incorporator of this corporation pursuant to Chapter 607 of the Florida statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such corporation.

ARTICLE I- NAME AND ADDRESS OF CORPORATION

The name of the corporation shall be Florida Fleet Transportation, Inc. The address of the corporation shall be 161 W. Landstreet Road, Orlando, FL 32824.

ARTICLE II-TERM OF EXISTENCE

This corporation shall exist perpetually.

ARTICLE III-NATURE OF BUSINESS

This corporation may engage or transact in any or lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.


ARTICLE VIII-AMENDMENT TO ARTICLES
