ARTICLES OF INCORPORATION

OF

BUILDING DREAMS, INC.

The undersigned incorporators hereby form and organize a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation is BUILDING DREAMS, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal office of the corporation is 10183 208th Circle, O'Brien, Florida 32071, and the mailing address of the corporation is 10183 208th Circle, O'Brien, Florida 32071.

ARTICLE III - TERM OF EXISTENCE

The corporation shall have perpetual existence starting on the date these articles of incorporation are filed with the Florida Department of State.

ARTICLE IV - PURPOSE

ARTICLE VI - REGISTERED AGENT AND OFFICE

The following limitations shall apply to the issuance,

These Articles of Incorporation may be amended, from time to time, in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the shareholders and approved at a shareholders' meeting by a majority of the stock entitled to vote thereon, unless all the directors and all the shareholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.
