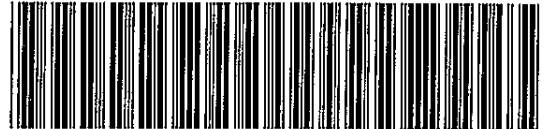

ARTICLE OF INCORPORATION

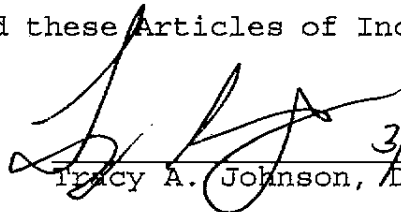
