ARTICLES OF INCORPORATION

OF

TIM'S TRACTOR & LANDSCAPING, INC.



The undersigned subscriber of these Article of Incorporation, a natural person competent to contract, hereby acts as an incorporator to form a corporation under the laws of the State of Florida and adopts the following Articles of Incorporation for such corporation.

ARTICLE I. NAME

The name of the corporation is TIM'S TRACTOR & LANDSCAPING, INC.

ARTICLE II. COMMENCEMENT OF EXISTENCE
