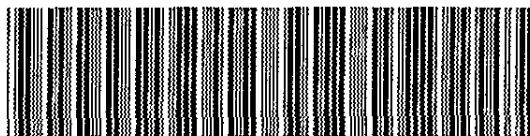

The undersigned subscriber of these ARTICLES OF INCORPORATION, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

Article I - Name

The name of this corporation is **FIVE STAR ROOM SERVICE, INC.**

Article II - Duration

This corporation shall exist perpetually, commencing upon filing.

Article III - Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

Article IV - Address

The initial principal place of business of this corporation is 7119 Sunset Ave., Panama City, Florida 32408 and the mailing address of this corporation is 7119 Sunset Ave., Panama City, Florida 32408.

Article V - Capital Stock

This corporation shall indemnify any officer or director or any former officer or director, to the full extent permitted by law.


Article XII - Amendment
