ARTICLES OF INCORPORATION

OF

PHIL HOUSTON APPRAISAL SERVICE, INC.

ARTICLE I - NAME:

The name of this corporation is: PHIL HOUSTON APPRAISAL SERVICE, INC., hereinafter referred to as the "Corporation".

ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing From the filing of the Articles of Incorporation with the Department of State.
