

## ARTICLES OF INCORPORATION OF RETAINERS BY JODI, INC.

The undersigned, acting as incorporator under-and by virtue of the laws of the Stafe of Florida, and particularly the Florida General Corporation Act, as provided in Chapter 667. Florida Statutes, and any acts supplementary thereto, adopts the following Articles of Incorporation for such corporation.

ARTICLE I
