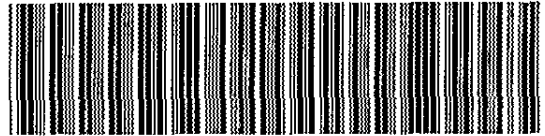

ARTICLE ONE
