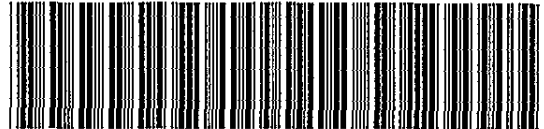

AMENDMENTS OF ARTICLES


