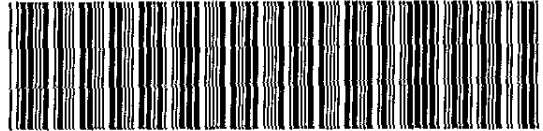

ARTICLE I

NAME

The name of this Corporation is HARMONY OF CITRUS COUNTY, INC

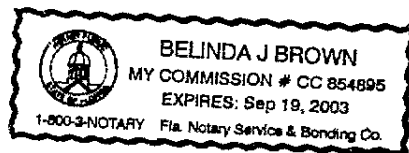
