Please be advised that our previous renewal of 4/20/2005 evidently was incomplete as our FEIN number was not included. However, your office informed me today, March 7, 2005, that a follow-up letter was sent to P.O. box 100391. This post office box was utilized by a total of 3 corporations located at the physical address 200 Ring Avenue, suite 107 (formally 110). The primary corporation, Emergency Check Printing Service, Inc., was in the process of being sold to a different entity (Emergency Check Printing, Inc.).

It's my understanding that the renewal fee was not returned with the follow-up letter, consequently the bookkeeping department (who were responsible for filing correspondence of all three corporations, filed the letter apparently not realizing that the form was incomplete.

Palm Bay Trading, Inc. has since its' inception been in the process of negotiating contracts and agreements and will be executing those agreements shortly.


I feel that the penalty for reinstatement will be an additional burden on my corporate finances at this time, I respectfully request a waiver of reinstatement fee, especially since the renewal fee was not refunded at renewal time. I have been unable to locate a cancel check due to hurricane damage to last years files, but will attempt to have my bank provide a copy of the canceled check for renewal.

The individual that I spoke with at the reinstatement office provided me with info on acquiring a reinstatement form. She indicated that a letter requesting reinstatement and a corrected form be sent to your office. If the waiver of reinstatement fee was approved a fee of \$150.00 will be required.

I have taken the liberty of enclosing the renewal fee of \$150.00 In the hopes that the waver will be approved and my corporation can be reactivated.
