ARTICLES OF INCORPORATION

The following Articles of Incorporation were drafted in compliance with Chapters 607 and 621 of the Florida Statutes.

Article I. Name

The name of the corporation is: Terry W. Covert & Associates, P.A.

Article II. Principal Office

Article III. Purpose

The purpose for which the corporation is organized is to provide legal counsel and services.

Article IV. Shares

Article VIII. Commencement and Duration


The PA shall commence upon the filing of these articles and shall remain as a perpetual entity or until statutorily terminated.


