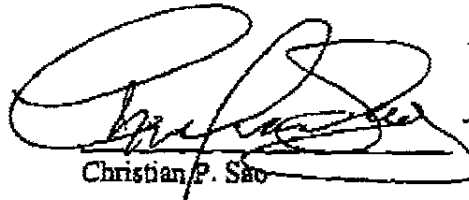
#### ARTICLE XI-AMENDMENT

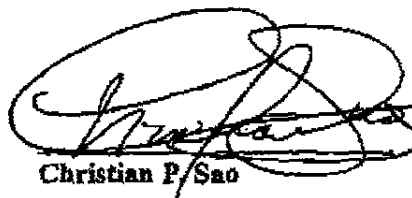
